#### 15) To receive a report regarding the Parkeston Cemetery

 No 2 Jamestown Close; a complaint received from residents supported by photographs in relation to lost light from the Oak Tree on the boundary of their property and the cemetery was identified as not being in the cemetery grounds. It was agreed that 2 hawthorn trees adjacent to the Oak tree is in need of addressing. Clive Dawson, TDC is to be invited for a site visit.

- Re-gritting of driveway: approximate 1 tonne needed quotation £41.90 delivered approved; the spreading of the grit will be addressed.
- Site visit: date to be agreed for a site visit of all members of the RPPC
- Recycling Plots: Cllr Prior, having been approached by a plot owner who has offered for the plot to be given back to the RPPC for re use, asked for advice. Plots are the responsibility of the owner for 50years; further information to be confirmed with relevant legislation.
