

Minutes of a Meeting of the Ramsey & Parkeston Parish Council held in the Parkeston Methodist Church Hall, Garland Road, Parkeston on Thursday 19th July 2012 at 7.00 p.m.

- 1. To accept apologies for absence: Cllrs Colbourne, Ramsay, Stertz
- **1a ECC** Cllr Skeels reported:
 - a) ECC Highways Panel: Cllr Skeels attended the first meeting of the panel, consisting of a membership of ECC councillors together with 3 TDC councillors and reported on issues covered:
 - Speed Reductions: a call for a 20mph zone along the entire length of The Street, Ramsay is to be taken forward on behalf of RPPC at the next meeting to be held 26/07
 - Road Maintenance: ECC have invested in new machinery [jet patcher] to address the district's problem with pot holes.
- 2. Code of Conduct: adoption of revised code and to receive revised Registers of Members' Interest
 - a) New Members' Code of Conduct: As required by the changes of the Localism Act 2012, Section 28 Cllr Singh proposed, seconded by Cllr L Donn that RPPC adopt the TDC new Code of Conduct as agreed to be consistent with the principles in Section 28, namely:
 - Selflessness, integrity, objectivity, accountability, openness, honesty and leadership.

The Chairman signed the New Code of Conduct, as previously copied to all members to take immediate effect.

b) New Registers of Members' Interest: As required by the Localism Act 2012, Section 29, all town and parish councils are under a statutory obligation in respect of declaring and registering interests and responsible to hold a register of interests available on both RPPC and TDC website, to this end all members' are to submit a revised register of interest for summary and submission to TDC Monitoring Officer.

 - Memorabilia held in the Church to be kept in Parkeston under the care of the RPPC
 - Litchgate and memorial plaques, recognised as a village memorial
